

September Ethics Case: Whose Line is it Anyway?

Ethical standards and principles are the foundation for maintaining public trust for every AFP member. Have you ever wondered what you would do when confronted with an ethical dilemma? In our Monthly Ethics Article, AFP Suncoast explores some common quandaries with Case Studies to help you test your knowledge.

September Ethics Case: Whose Line is it Anyway?

A small, fundraising company retains the services of a freelance web specialist to re-position and re-design its web presence, in order to more effectively exploit this channel for its marketing efforts. The company is delighted with the results of her work and the value for money offered.

Unfortunately, what the company does not know is that the designer has plagiarized some of the new material introduced onto the website, and that the intellectual property (IP) owner has not been properly credited.

- A. Is the company in violation of the Code of Ethical Principles?
- B. Suppose the company were informed of the violation by the IP owner, and referred the matter to its next board meeting, three months hence, for a decision on what action to take. Would this be a violation of the Code?
- C. The company approaches the web designer to demand that she rectifies the situation, and either properly credits, or removes, the offending material. The designer demands a further fee for so doing, which the company refuses to pay on principle. Is the company in violation of the Code?
